

Cap-n-Corks Wine Extravaganza

Official Rules

1. Cap-n-Corks Wine Extravaganza is meant to be an informal friendly, fun, head-to-head home winemaking competition based on the UC Davis 20 Point Tasting System.
2. Wines will be judged using UC Davis 20 point Tasting System score sheets by locally selected judges in the following categories:
 - Red Grape Varietals
 - White Grape Varietals
 - Grape, & Fruit Blend Varietals
 - Open Fruit
 - Open Vegetable, Herb
 - Hard Cider & Honey Wines ~ Mead/Melomel/Pyments

The best from each category will be judged as a group for overall Grand Champion based on judge's decision. Additionally each entry is automatically eligible for the "Best Label" contest. It is the responsibility of the entrant to select the appropriate category for their particular wine entry/entries.

3. Contestants must fill out an entry form, pay necessary entry fees and submit **two** 375ml bottles or bigger per category entered. Entry is required no later than 12pm February 25, 2012 to be eligible. Entry forms may be filled out and fees paid starting February 7, 2012 at Cap-n-Corks located in the Kings Plaza ~ London Road, Eau Claire. Wine submittals may be brought in starting February 7, 2012.
4. Each entrant will submit a \$5.00 non-refundable entrant fee. This fee will include entry of 1 wine in any particular category. Each additional wine entry will be an additional \$1.00 regardless of category. Contestants may enter as many categories and as many wines as they wish as long as said fees are paid. All entries are automatically entered in the "Best Label" contest. Anyone wishing to enter this additional contest without submitting a wine in one of the 5 categories must still submit an entry form and pay the \$5.00 entry fee.
5. Bottle submittals will be two 750ml or 375ml bottles **without label** or identification and one label (not on a bottle) of entrant's choice per entry. (*Please note: Labels containing vulgar language, profanity, nudity or other in poor taste will be rejected.) Contestants are responsible to keep entries segregated until bottle ID #s are assigned by Cap-n-Corks personnel. Entrant's bottles will be available for pickup at the conclusion of contest (approximately 4:30pm – February 25, 2012). All bottles left after close of business March 11th, 2012 become property of Cap-n-Corks, LLC. No Exceptions.
6. **Prizes –**
 - **Best in Class** (5 Each) ~ \$25 Cap-n-Corks Gift Certificate
 - **Grand Champion** (1 Each) ~ \$50 Cap-n-Corks Gift Certificate
 - **Best Label** (1 Each) ~ \$10 Cap-n-Corks Gift Certificate
